



TERMS & CONDITIONS

Please read the following and sign at the bottom of the page.

1. Cooling off Period

If you notify us, in writing and within five (5) days from the date of signing this form, that you wish to cancel your enrolment, then we will refund you the total amount you have paid less the value of any product received with your enrolment, i.e. products are non-returnable. This period is waived if a program/seminar is paid for within 5 days of the start of that day.

2. Product Warranty

If any product you receive with your enrolment is found to be faulty, our only obligation to you is to replace the faulty product within 14 days of your written request.

3. Rescheduling Your Appointment

If you find you are unable to attend the program/seminar on the dates for which you have enrolled, you may transfer your enrolment, without any penalty, to the same program/seminar that Your Future Now Pty Ltd may convene provided you do so within two (2) years of the original seminar date. Any transfer is subject to seats being available in your preferred program/seminar at the time you make the request. 4. Program / Seminar Changes

In this case you retain the right to reschedule your enrolment in accordance with paragraph 3 above, and you shall have no claim upon us for a refund or compensation.

5. Program / Seminar Cancellation

If for any reason it is necessary to do so, we may cancel the program/seminar by notifying you in writing. In this case we will refund the total amount you have paid for your enrolment or put it towards credit for another program/product, and you shall have no claim upon us for compensation. In this case you retain the right to reschedule your enrolment in accordance with paragraph 3 above.

6. Enrolment Option fee

We will not accept your enrolment until we receive a payment from you equal or greater than the minimum option fee required for the program(s)/seminar(s) you are enrolling in (minimum option fee being 33% of the cost of the program).

7. Enrolment Cancellation

If you choose to cancel your enrolment for any reason, other than within the cool-off period identified in paragraph 1, you will receive a credit for the total amount you have paid less the full retail value of any products received with your enrolment. Credits may not be claimed as cash refunds; but may be applied towards an enrolment in any other program/seminar offered by Your Future Now Pty Ltd two years from original enrolment date.
